Thank you for your interest in the Peninsula Tennis Club.

While there are no designated criteria for or required characteristics of a prospective applicant, the experience of our Membership Committee suggests that some guidelines are appropriate. Therefore, it is strongly recommended that if you choose to sponsor a prospective member, you can attest to the following:

- 1) The applicant is well known to you, preferably for more than two years;
- 2) The applicant has a demonstrated interest in the game of tennis;
- 3) The applicant is well known to at least one additional member, who will act as a reference, and who has socialized and played tennis with the applicant on more than one occasion;
- 4) The applicant is familiar with PTC, has toured our facilities, and has visited our website (www.peninsulatennisclub.org);
- 5) The applicant is willing and able to participate in club events and play on our USTA teams;
- 6) The applicant's behavior at the club, both during the application process and once granted membership, is a reflection on you as a sponsor, and you are responsible for helping him/her maintain the spirit of the club.

The above are suggested guidelines. These guidelines reflect matters considered to be very important to the Membership Committee, and are used solely as an aid in evaluating the application for membership.

Action Items That You Need To Complete:
